
### Amount of EMD / performance Security as under:

- 1. Rs 10,000/ = (Ten thousand only) in the shape of DD, FDR.Tender not accompanied with the required amount of EMD will not be entertained. ( CDR WILL NOT BE ACCEPTED)
- 2. The EMD of the unsuccessful bidders will be returned after the selection of the successful bidders.
- 3. The EMD shall be forfeited if the Bidder withdraws its bid during the period of bid validity.
- 4. EMD will be forfeited if a bidder refuses to supply the requisite demanded item as per the supply order.
- 5. The EMD in favour of the successful bidder shall be released on submission of Performance Security as per the provisions of GFR-2017.


#### Cover (2nd): Financial bid:

- 09. The CHAIRM-AN STUDENTS MESSS NIT SRINAGAR may, for any reason, whether suomoto or in response to a clarification requested by a prospective bidder, modify, the bidding documents by an amendments at any time prior to the last date for submission of bids.

  - Tender will be terminated if supplier provides item having exceeded the expiry dates. 18)

- 24) The successful tenderer (hereafter called supplier) has to deliver the item at the mess stores within 24 hours after receipt of demand slip and placing the gate entry of supplies will be the responsibility of the supplier and any negligence for the will not be accepted.
- The highest discount rates to be offered by the bidder shall be valid and applicable for a period of one year with effect from 01.0 4.2025 to 31.03.2026.
