Resolution No. 03/112	On the recommendations of the Finance Committee, the Board of Governors approved the proposal for creation of additional infrastructural facilities i.e. construction of four number classrooms, 30 number of faculty rooms, two Conference Rooms (G+3) and a Health Centre (G+1) for Economically Weaker Sections (EWS) for admission in Central Government Educational Institutes at the estimated cost of Rs. 9,70,56,000/-and Rs.5,86,87,800/- respectively. The BOG was informed that the estimated cost of construction of new Health Centre (G+1) was made only for civil and electrical part. The Medical Unit of NIT Srinagar is well equipped with all the required machinery

	and all the equipments will be shifted to New Block once ready. No expenditure will be incurred on the purchase of medical equipments out of EWS funds.  Further, BOG resolved to submit a separate proposal for the remaining amount of Rs. 5.43 crores (purchase of library books / softwares / networking of hostels) and get the same approved by FC / BOG through circulation.
