Candidates, who have secured admission in NIT Srinagar in different Engineering Branches for the academic year 2022-23 through JOSAA 2022, and have freezed their seat at NIT Srinagar are hereby informed to note the following:

1. The Physical reporting for B.Tech Batch 2022 shall commence from **1<sup>st</sup> November, 2022 to 4<sup>th</sup> November, 2022** (only for those candidates who have secured seat in JOSAA 2022 except CSAB 2022)
2. Those candidates who are participating in CSAB Special Rounds and will secure their admission (through CSAB) are hereby informed that their physical reporting will commence from **4<sup>th</sup> November, 2022 to 6<sup>th</sup> November, 2022**.
3. All candidates are hereby informed to register themselves through online admission portal. The link for the same will be notified well before physical reporting through Institute website
4. Candidates are required to deposit the balance Institute fee at the time of physical reporting in the Institute. The fee structure is available on Institute website.
5. Regular Class work in person shall commence from 7<sup>th</sup> of November, 2022.
6. The candidates selected through DASA 2022 will report for the completion of admission formalities during the above point 1.
7. The candidates are advised to bring the warm clothing with them, as winter is approaching.
8. Documents to be produced at the time of physical reporting is given below:
  - a) Class X Mark Sheet/Certificate, Aadhar Card (for Date of Birth)
  - b) Class XII Mark Sheet and Certificate (Qualifying Examination)
  - c) Certificate of category (SC/ST/OBC-NCL/GEN-EWS), if applicable, as per Government of India format, available on the JoSAA 2022 website, issued by the competent authority.
    - i. In case of OBC-NCL/GEN-EWS category, the certificate must be issued on or after April 01, 2022.
    - ii. Please note that (i) Caste certificate (SC/ST/OBC-NCL) issued by Maharashtra State must be validated by Social Welfare department (in case of SC and OBC-NCL category) and Tribal Welfare department (in case of ST category) of Maharashtra Government. The SC/ST/OBCNCL candidates of Maharashtra State have to produce their caste validity certificate in the format available on JoSAA 2022 website.
    - iii. ST certificates from Tamil Nadu state must be issued by the concerned Revenue Divisional Officer.
  - d) Original Certificate for Persons with Disabilities (PwD), if applicable, issued by the competent authority.
  - e) Income Certificate (should be issued after 1<sup>st</sup> April, 2022 and should be issued by not below the rank of Tehsildar)

- f) Medical Certificate (in specified Format available on JoSAA 2022 format)
- g) Provisional Admission Letter generated from JOSAA/CSAB 2022.
- h) Document Verification Letter generated from JOSAA/CSAB 2022.
- i) Admit card of JEE (Main)
- j) Character Certificate (from last attended School/Institute)
- k) Migration/Transfer Certificate (from last attended School/Institute).
- l) 06 Passport size colored photographs in formal clothing with light blue background.
