- कानून के नियमों के अनुसार कानूनी एक्शन।

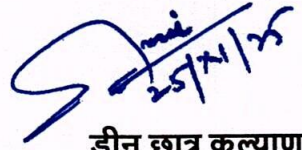

- **Legal action** as per the provisions of law.

Students are advised to exercise utmost caution and responsibility while using social media and to uphold the dignity and values of the Institute at all times.

Social Media Usage Policy

I. General Principles of Conduct

- **Personal Responsibility**: Students are solely responsible for all content shared on any social media platform, including private groups or messages.
- **Professionalism & Respect**: Posts must be respectful and free from harassment, bullying, hate speech, or derogatory remarks against any individual or community.
- **Representation**: No student shall claim to represent the Institute without prior written permission. Personal opinions must not be presented as official statements.

II. Prohibited Content and Activities

Strict disciplinary action will be taken for:

- Sharing confidential or non-public information, including internal data, disciplinary matters or personal images/details without consent.
- Posting defamatory, false or malicious content against the Institute or any member of the community/institute.
- Uploading, promoting or engaging in illegal activities, violence, drug use or cybercrime.
- Unauthorized use of the Institute's logo, seal, documents or copyrighted material.
- Impersonation of another person or an Institute authority.
- Sharing obscene, explicit or inappropriate content.
- Posting grievances publicly on social media instead of using the Institute's official grievance redressal mechanisms.

III. Privacy and Safety Guidelines

- Think carefully before posting. Online content is permanent and may impact future opportunities.
- Use appropriate privacy settings but remain aware that content can still become public.
- Avoid sharing personal information such as home addresses, phone numbers, or real-time location.
- Be cautious when interacting with unknown individuals or accepting follow/friend requests.

IV. Enforcement and Consequences

Violations of this policy may lead to:

- Suspension or restriction from institutional activities.
- Withdrawal of scholarships, leadership roles or placement privileges.
- Expulsion from the Institute in severe cases.
- Legal action under applicable laws, including the IT Act.
- Mandatory removal of objectionable content with further action if not complied with.

All students are advised to use social media responsibly and uphold the values and dignity of the Institute.
