
**Guidelines for candidates confirming B. Tech. admission in NIT Srinagar in various Branches of Engineering for the year 2020 through JOSAA/CSAB 2020.**

**Dear candidates,**

A warm welcome to you all on behalf of NIT Srinagar for qualifying JEE 2020 and obtaining a seat in NIT Srinagar for the year 2020. Wish you all success in this new era of your academic journey. We are equally jubilant and pleased to receive you on the campus. Wishing the day come soon!!

Now, after completing your admission formalities at JOSAA portal / CSAB-2020, you are supposed to confirm your admission by reporting to NIT Srinagar in person as per guidelines. But in view of Covid-19 pandemic, physical reporting has been avoided till further orders. However your provisional confirmation of admission in NIT Srinagar shall be made online. Subsequently your class work shall also take place through online mode only from 1<sup>st</sup> week of December, 2020. Your class work will start with an orientation programme. For all details you are informed to be in touch with the Institute website [www.nitsri.ac.in](http://www.nitsri.ac.in)

Regarding confirmation of your admission in NIT Srinagar, candidates with Open/OBC/EWS category (with an annual income of more than Rupees 05 lacs) are supposed to pay extra fee to be notified separately. SC/ST/PWD candidates and candidates whose annual income is less than 5 Lacs need not to pay an extra fees. The excess amount paid by these candidates during JOSAA rounds and during admission confirmation shall be carried forward for subsequent semester under rules. Meanwhile you are hereby informed to do the following for provisional confirmation of your admission and obtaining an enrolment No. for future academic activities in the Institute.



- A Google form has been generated and will remain available at Institute website [www.nitsri.ac.in](http://www.nitsri.ac.in) from 11<sup>th</sup> November, 2020 (under tab Admission / online Admission).
- All candidates who have frozen their seats / admission in NIT Srinagar during JOSAA-2020 rounds (Round 1-6) and do not want to participate in CSAB Special Rounds, are advised to fill in the required details in the available Google form (under tab Admission / online Admission) by or before 15-11-2020.
- Those candidates who want to participate in CSAB-2020 are advised to fill in the required details in the available Google form (under tab Admission / online Admission) from 25-11-2020 to 26-11-2020.
- After submitting the Google form, you will get the login details and link for obtaining enrollment and filling your personal academic credentials in your e-mail id.
- After obtaining above details in e-mail id you are required to open the link and submit your requisite details.
- After successful submission of your credentials your enrollment process shall be completed. You will record your enrollment No. / Registration No. for all your future academic activities during the course.
- After completing above steps, your online reporting is over. You will get the link from your concerned Department / faculty incharge for online classes in due course of time.


**Note:**

1. Admission of all candidates is provisional and is subject to the fulfillment of eligibility conditions as laid down in the JOSAA / CSAB 2020 business rules and the submission of original documents at the time of physical reporting in the Institute

2. The OBC/ EWS certificate to be submitted at the time of physical reporting should be as per JOSAA format and the issuance date on the certificate should be after 1st April 2020, as per JOSAA business rules.

4. Candidates whose annual income is less than 5 Lacs and want to avail fee concession / fee waiver from the Institute are supposed to submit **annual family income certificate** from all sources duly signed by Tehsildar.
