➤ **Eligibility Criteria for Admission to MBA Degree at NIT Srinagar**

Eligibility for MBA Program:

- A graduate degree under 10+2+3 or 10+2+4 pattern under any discipline, securing at least 60% marks or 6.5 CGPA in aggregate, from a recognized university (for OM/EWS/OBC).
- For SC/ST/PWD candidates, there shall be a relaxation of 5% in the aggregate marks obtained i.e. 55% Marks or 6.0 CGPA at the graduation level.

The selection of the candidates for admission to the MBA programme is a two-step process.

The MBA admission criteria shall be based on:

- Step I: A valid score of Common Admission Test (CAT) or Common Management Admission Test (AICTE-CMAT). Preference will be given to candidates with a valid CAT score.
- Step II: Group Discussion (GD) & Personal Interview (PI).

Selection will be based on the overall merit of the candidates scored in both Step I & Step II.

- In case seats remain vacant, the Department shall conduct an Institutional level test followed by Group Discussion & Personal Interview for admission process.
- The Institutional level test shall be conducted on the following lines:

Number of sections	4 (Quantitative Techniques and Data Interpretation, Logical Reasoning, Language Comprehension, General Awareness)
Duration of exam	90 minutes
Number of questions	60
Total Marks	60
Number of answer choices	4
Marking scheme	1 mark for each correct answer with negative marking of 0.25 per Wrong answer.
Language of paper	English
Selection will be based on merit in the Written Exam, Group Discussion & Personal Interview. The weightage given to GD and PI shall be in accordance to the guidelines set by the Institute


The selection will be provisional subject to the verification of the following documents in original and fulfillment of requirements as per the statutes and advertisement.

- V. 10+2 marks card and qualification.
- VI. UG grade/marks card.
- VII. UG Degree certificate/ Provisional Degree certificate.
- VIII. Migration certificate.
- IX. Character certificate and transfer certificate.
- X. Candidates need to upload all the above cited certificates/ documents at the time of online filling of the application form.
