ADVERTISEMENT NOTICE

Applications are invited for admission to MBA (Master of Business Administration) Programme offered by the Department of Humanities, Social Sciences and Management, NIT Srinagar for the Academic Session Autumn- 2024.

Eligibility Criteria for Admission to MBA Degree:

A graduate degree under 10+2+3 or 10+2+4 pattern in any discipline, securing at least 60% marks or 6.5 CGPA in aggregate, from a recognized university for OPEN/EWS/OBC and for SC/ST/PWD candidates 55% Marks or 6.0 CGPA at the graduation level. Only primary mode of evaluation (CGPA or percentage) as mentioned in the qualifying degree certificate / marks sheet(s) shall be considered while verifying eligibility.

The selection of the candidates for admission to the MBA programme is two-step process.

The MBA admission criteria shall be based on:

Step I: A valid score of Common Admission Test (CAT) or Common Management Admission Test (CMAT) or Management Aptitude Test (MAT).

Step II: Group Discussion (GD) & Personal Interview (PI).

Selection will be based on the overall merit of the candidates scored in both: Step I & Step II.

In case seats remain vacant, the Department may conduct an Institutional level test followed by Group Discussion & Personal Interview for admission process.

The candidates who do not have a valid CAT / MCAT / MAT can also apply, However it is emphasized that Institutional level test will only be conducted if seats remain vacant as per the seat matrix.

The Institutional level test shall be conducted on the following lines:

Number of sections	Quantitative Techniques and Data Interpretation, Logical Reasoning, Language Comprehension, General Awareness
Duration of exam	90 minutes
Number of questions	60
Total Marks	240
Number of answer choices	4
Marking scheme	4 marks for each correct answer with negative marking of 1 mark per Wrong answer. Blank answer will be given 0 mark.
Language of paper	English
Selection will be based on merit in the Written Exam, Group Discussion & Personal Interview. Candidates will have to be present in all the 3 components so as to be considered for the admission. The weightage given to GD and PI shall be in accordance with the guidelines set by the Institute

The candidates have to apply online using the link <https://admission.nitsri.ac.in/> Candidates are required to pay application processing fee of Rs: 1500 (One Thousand and Five Hundred only) for General/OBC-

NCL and Rs.750 (Rs Seven Hundred and Fifty Only) for SC/ST/EWS/PwD through online mode. Applications will be screened by concerned Department and list of eligible candidates will be available on Institute website: www.nitsri.ac.in. All announcements related to admissions will be made through NIT Srinagar website. All candidates are advised to keep in touch with the Institute website till the process of enrolment is complete.

The selection will be provisional subject to the verification of the following documents in original and fulfillment of requirements as per the statutes and advertisement.

Documents (as Applicable) to be uploaded along with application:

1. Matriculation (DoB) certificate.
2. CAT/CMAT/MAT valid score card.
3. Graduation grade/marks card
4. Degree / Provisional certificate
5. Migration certificate.
6. Character certificate and transfer certificate.
7. Schedule Caste / Schedule Tribe / PwD Certificate / OBC (NCL) Certificate / EWS certificate.
8. In case of OBC-NCL/GEN-EWS category, the certificate must have been issued on or after April 01, 2024.
9. The authorities competent to issue Category/Caste Certificates are indicated below:
10. District Magistrate / Additional Magistrate / Collector / Deputy Commissioner / Additional Deputy Commissioner/ Deputy Collector/ First Class Stipendiary Magistrate / Sub-Divisional magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner (not below the rank of 1st Class Stipendiary Magistrate), Chief Presidency Magistrate / Additional Chief Presidency Magistrate / Presidency Magistrate, Sub-Divisional Officer of the area where the candidate and / or his family resides, Revenue Officer not below the rank of Tehsildar.
11. Candidates whose final year result is yet to be declared are also eligible to apply, however they have to submit their certificate / marks card at the time of enrolment, if selected. They should enter 00 in the Percentage/CGPA field. They should also upload the complete transcript of marks / grade up to last but one semester / year.


