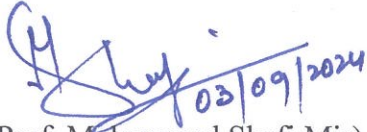

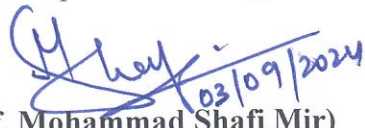

  - ST certificates from Tamil Nadu state must be issued by the concerned Revenue Divisional Officer.
