All of the lectures have been videotaped and published on multiple platforms, such as the faculty's YouTube channels, so that students with limited internet access will not be left behind and will be able to participate in the lectures in an offline mode. Faculty members have recorded recordings of lab sessions, as well as online discussions with students, in order to provide a more comprehensive learning experience. Additionally, virtual labs supplied by various IITs have been held in conjunction with these sessions to facilitate the transmission of knowledge. Dean Academics has published guidelines from time to time to ensure that the syllabus of a course has been finished and that no one is left out of the loop.
