1. Admission shall be provisional, subject to fulfillment of statutory norms and as per the admission guidelines and production of original documents for verification as mentioned in the advertisement Notification.
2. All the documents should be available (in original) at the time of admission, failing which the provisionally allotted seat will be forfeited. No representations will be entertained for late submission of any documents beyond the due date.
3. For candidates in reserved categories, the production of valid category certificates is mandatory at the time of admission. In case of OBC-NCL and EWS category, the certificate must have been issued on or after 1<sup>st</sup> April, 2025, by the competent authority not below the rank of Tehsildar or a Government issued, online verifiable certificate which must be valid till August 31, 2025 or the day of physical reporting at the admitting institute, whichever is later.
4. PwD Candidates will be assessed by the Medical Board at the time of admission. Admission under the PwD category will be subject to the condition that the candidates has disability not below 40% as assessed and reported by the Medical Board.
