Subject: Submission of correct annual income certificate under the Scholarship for National Fellowship and Scholarship for Higher Education of ST Students.

Sir/Madam.

I am directed to refer to the subject mentioned and to say that it has come to notice of the Ministry that fresh category students are submitting incomplete income certificates when applying for scholarships (fresh application). Specifically, they are submitting either their father's or mother's individual income certificate instead of a combined family income certificate.

- 2. To ensure compliance with the scholarship guidelines, the Ministry requests that all fresh applicants to submit a combined family income certificate issued by a competent authority. This certificate should reflect the total income of both the parents. The student can either merge their individual father's and mother's income certificates or submit a single family income certificate that includes the total family income.
- 3. For further clarification, Part B of the National Scholarship Scheme, paragraph 2.2, of the National Fellowship and Scholarship for Higher Education of ST Students Scholarship (formerly Top-Class Education for Schedule Tribe Students) scheme guidelines may be seen (copy enclosed).
- 4. In view of above, it is requested to ensure that all applicants (fresh cases) submit the correct document and also to inform the fresh applicants to obtain the correct income certificate from the competent authority. For students who submit the incomplete income certificate, please mark it as defective and return it to the students for re-submission.







- (2) The applicant/ family shall be responsible / accountable to declare any addition in the income from any sources during the period of validity.





## Income criteria - Scheme Guideline

- 2.2 Income Criteria: The total family income of the student to be eligible for this scholarship from all sources should not exceed Rs.6.0 lakh per annum. The family income shall be computed in the following manner:
  - i. In case where both father and mother are working, the combined income of both of them from all sources shall be takeninto account in computing total family income.
  - ii. In case any other member of the family, other than father and mother is an earning member, his or her income shall not be included in computing total family income.
  - iii. In case only one parent is alive, the income of that parent shall be taken into account for considering total parental income. If other sibling or family member is an earning member, their income shall not be included in computing total family income.
  - iv. In the case of an orphan, supported by a guardian, income criteria shall not apply.
  - v. In case of married candidates, the spousal income will also be added to compute total family income.
