
Following is notified:

1. Admission shall be provisional, subject to fulfillment of statutory norms and as per the admission guidelines and production of original documents for verification as mentioned in the advertisement notification.
2. All the documents should be available (in original) at the time of physical-reporting/admission.

3. For candidates in reserved categories, the production of valid category certificates is mandatory at the time of admission. In case of OBC-NCL and EWS category, the certificate must have been issued on or after 1st April 2024, by the competent authority not below the rank of Tehsildar.
4. PwD Candidates will be assessed by the Medical Board at the time of admission. Admission under PwD category will be subject to the condition that the candidate has disability not below 40% as assessed and reported by the Medical Board.
5. Candidates are advised to complete their admission formalities during **21st October 2024** in the PhD Section of the Institute.
