Note: Before taking the possession of respective quarters, an allottee has to fulfill the following terms and conditions as per allotment rules of the Institute. This allotment shall be deemed to be cancelled for those allotees by ab-initio who fail to comply with the terms and conditions given hereunder:

- 1. All estates allotments in NIT Srinagar are governed by the rules published by Directorate of Estates, Ministry of Urban Development (GOI) or any other Central Government gazette (i.e. Govt. of India notifications) rules / guidelines for quarter allotment / recovery of charges thereof issued from time to time which are binding upon all residents.
- All recovery charges (HRA, License fee, water charges, and electricity consumption fee) shall be recovered from the monthly emoluments / salary of the residents.
- 3. All residents have to comply with renovation policy of P&D wing that requires temporary shifting necessitated to complete renovation works in the campus.
- 4. 12 Residential quarters (Type L) shall be reserved at all times for temporary shifting of existing residents to complete renovation of at least two blocks of L-type at a time. Accordingly, allottees for L-type quarters from S. No. 11 to 22, shall have to submit an undertaking from first class magistrate to the effect that their allotment for claim of occupancy in their respective allotted L-quarters is valid only when renovation is complete in all blocks of L, A & P type quarters. No occupancy whatsoever shall be allowed in these reserved L-type quarters till renovation work is complete.
- That during the tenancy, the above allottee shall be personally responsible for proper upkeep of the residential quarter and damages caused beyond fare wear and tear to the property of NIT Sringgar.



- 6. That if the allottee sublets the residential quarter allotted to him/her or any portion thereof in contravention of "National Institute of Technology, Srinagar, house allotment rules" he/she may, without prejudice to any other action that may be taken against him/her, be charged damages.
- 7. That the officer/official to whom a residence has been allotted shall maintain the residence in premises in a green condition to the satisfaction of the Estates officer.
- 8. That the officer/official shall ensure that no additions or alteration are to be made in the building or wall to be disfigured or temporary structure to be erected in a house allotted or Electrical or Water connection are not tempered with and no extensions from them are carried out.
- That an employee to whom the residence has been allotted shall not or permit to cut down the trees, plants or shrubs in the premises or change the shape of the area allotted to him/her without the permission of Estate officer.
- 10. The allottee will ensure that the inventory register is signed by him/her and that all the accessories/ fixtures i.e Water supply, Sanitary installations and Electrical installations are in place. Similarly, while vacating the house all the accessories and fittings should be in order and keys shall be handed over to the authorized representative or the Estate officer.
- 11. No dues certificate will be obtained by the individual from the Estate officer while vacating the house. Any breakage shall be responsibility of the occupant and its cost thereof shall be the recovered from him/her or his/her pending dues with the NIT Srinagar.
- 12. Above terms and conditions are not exhaustive and this allotment is subject to all rules in vogue in Estates and constituting "National Institute of Technology, Srinagar-House Allotment Rules".
- 13. All the officers/officials are requested to take possession of their respective residences from the Estates officer or his authorized representative.
- 14. However, in case any of the above officer/official fails to accept the allotment of the residence within three (03) days as per availability mentioned above and take the possession of the quarter within one week from the date of receipt of this letter subject to availability of the quarter as ready to move for occupation, his/her allotment shall be liable to cancellation and he/she shall not be eligible for another allotment for a period one year from the date of this allotment letter as per House allotment rules.
